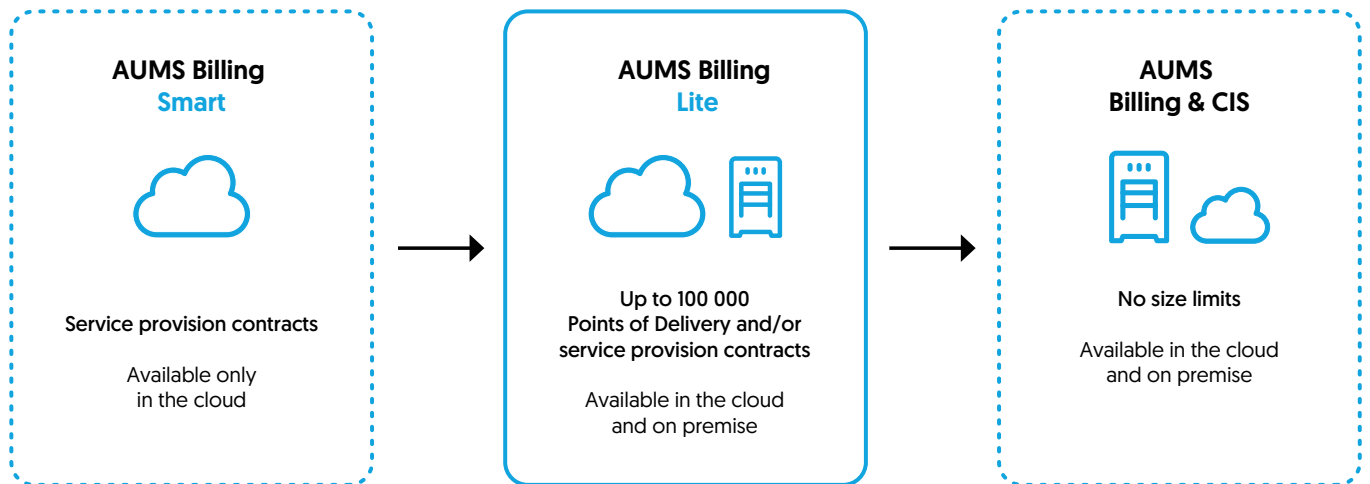

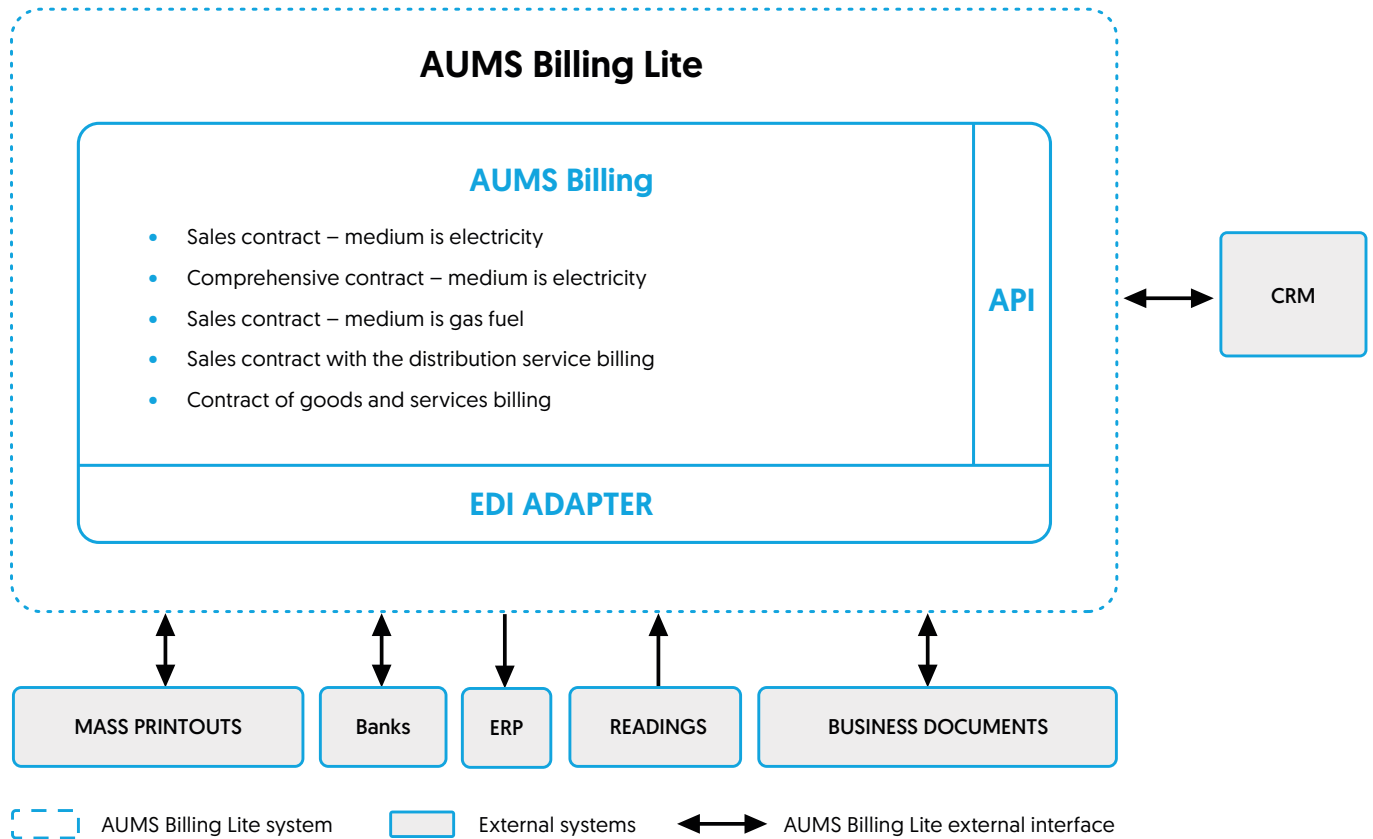

System logic architecture.



Solution components:

- **AUMS Billing** – billing of customers of electricity and gas fuel on the basis of sales contracts and comprehensive contracts, financial services, debt collection and reporting
- **API** – data exchange, including in particular the acquisition of clients and signed contracts from the CRM system, and the export of necessary data to the CRM system
- **EDI ADAPTER** – data exchange in EDI format

Interfaces:

- **CRM** – acquiring of clients, Points of Delivery and signed contracts for invoicing
- **Banks** – import of payments collection and handling of Direct Debit
- **Mass printouts** – export of data to a mass printing system
- **ERP** – export of data on the turnover of accounts
- **Readings** – import of measurement and billing data
- **Business documents** – exchange of business documents in EDI format

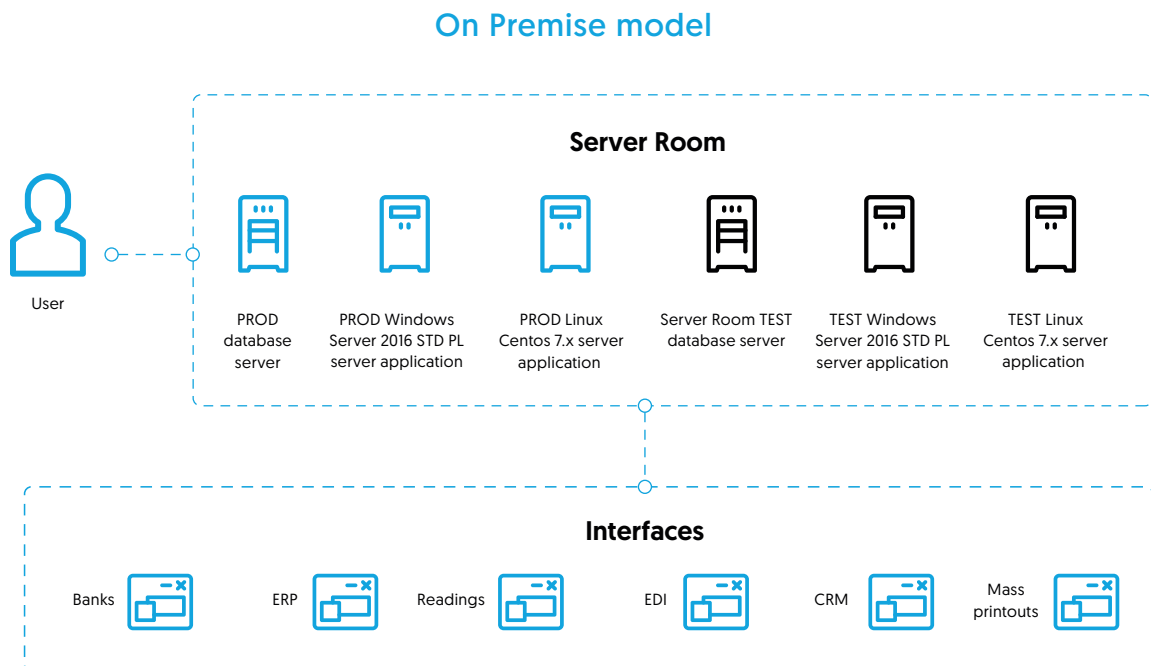

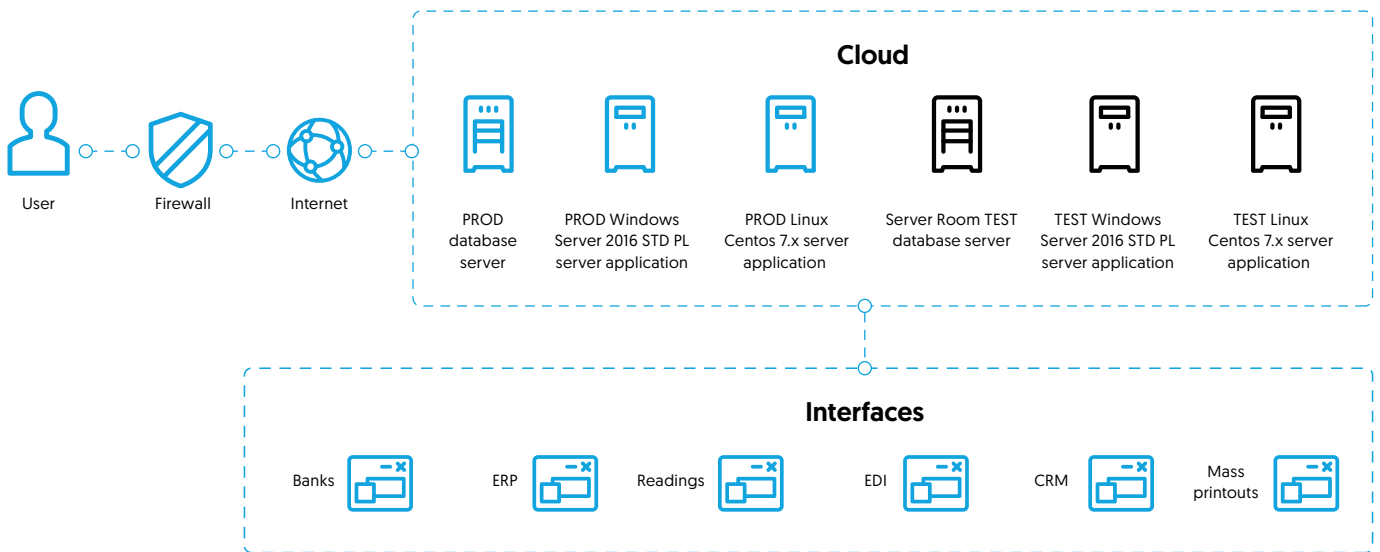

System technical architecture.

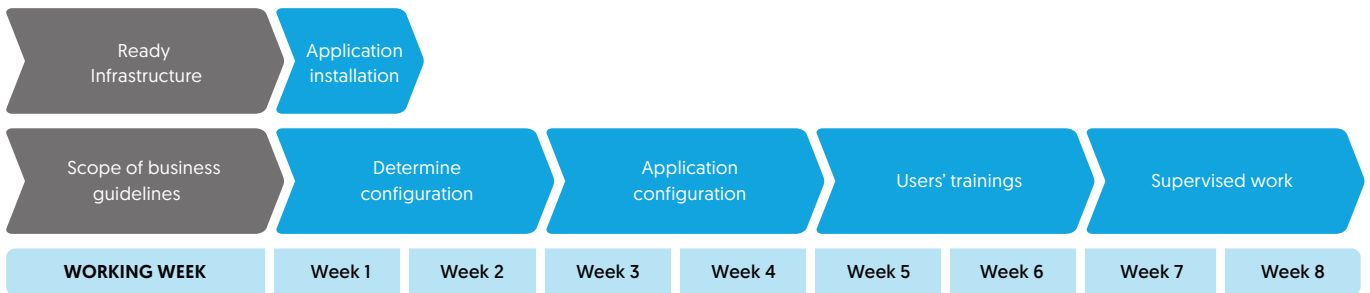


SaaS model



Short implementation schedule.

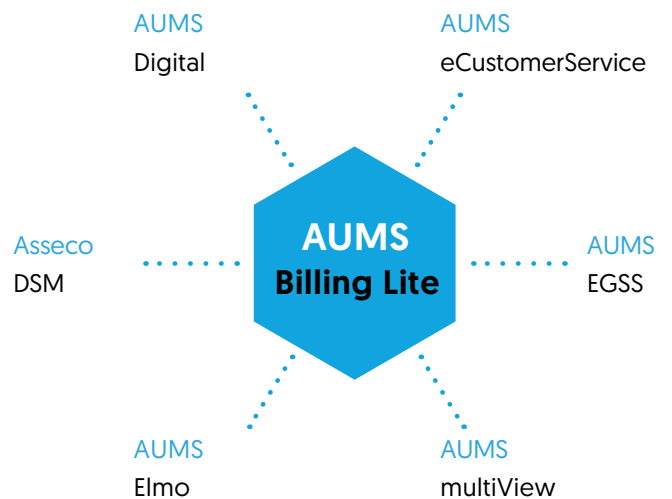
The system has been designed in a way that allows the work to commence within two months from the time implementation is started. This time applies to both **the SaaS** and **on premise** models.
